

Terms & Conditions

1KG Gold Bar Promotion

01 GENERAL PROVISIONS

1.1 The name of the Promotion is “1KG Gold Bar from NBH MARKETS”.

1.2 The Offer is organised by NBH MARKETS financial group (hereinafter called NBH MARKETS).

1.3 The main prize of the Offer is 1KG Gold Bullion Bar or its equivalent in money, 40000 USD (This amount is subject to change, depending on the actual price of gold on the final day of the Promotion), or a BMW X5 worth 40,000 USD.

1.4 The period of the Offer is from May 22, 2019 to December 31, 2020 (hereinafter called the Period of the Promotion).

02 PARTICIPANTS OF THE PROMOTION

2.1 Any legal person, who has registered with NBH MARKETS for a trading account, by default shall be participating in the Offer (hereinafter called the Client).

2.2 The NBH MARKETS trading account opened via NBH MARKETS official website is a live trading account for MetaTrader4 or MetaTrader5.

2.3 To join the Offer, the Client shall meet the following requirements:

2.3.1 The Client has to pass passport and address verifications successfully.

2.3.2 The Client's trading volume (closed transactions only) has to be equal to 20 standard lots for the Client to receive a coupon. The Client shall receive one coupon every time they trade 20 lots from the start date.

2.4 Partners of NBHM will earn a coupon for every 120 lots traded.

03 ENTRIES

3.1 The participation coupons are given to Clients from the first day of the Offer until and including its last day, i.e. December 31, 2020, till 23:59:59.

3.2 The total maximum number of coupons is 8,999.

3.3 Each coupon has its unique identifier number.

3.4 After the Client receives his first Coupon (as well as the following ones), the numbers that show the Client's trading volume is reset and calculated all over again.

3.5 The number of Coupons that may be received are calculated separately for each of the Client's trading accounts.

04 PRIZE NUMBER

4.1 The prize number will be the 4-digit number from "0000" to "9999".

4.2 The quotes of EURUSD, GBPUSD, XAUUSD, and XAGUSD currency pairs are monitored on the Meta Quotes trading servers.

4.3 The prize number will consist of the last digits of Bid quotes of these symbols: of EURUSD, GBPUSD, XAUUSD, and XAGUSD.

4.4 The first digit of the prize number is the last digit of EURUSD quote of trading pair on December 31, 2020, at 23:59:59.

4.4.1 The second digit of the prize number is the last digit of GBPUSD. Quote of trading pair on December 31, 2020, at 23:59:59.

4.4.2 The third digit of the prize number is the last digit of XAUUSD. Quote of trading pair on December 31, 2020, at 23:59:59.

4.4.3 The fourth digit of the prize number is the last digit of XAGUSD. Quote of trading pair on December 31, 2020, at 23:59:59.

4.5 On the last day of the Period of the Offer, the last digits of the quotes on the above-mentioned symbols are recorded (the end of quoting is at 23:59:59 EET, December 31, 2020).

4.6 The prize number will consist of the digits of the last quotes of the symbols recorded at the abovementioned time.

05 ELECTION OF THE WINNER

5.1 The winner of the Offer is the Client, whose Coupon number matches the prize number.

5.2 If the prize number is different from the number of any given Coupon, the winner of the Offer is the Client, whose Coupon number is closer to the prize number.

5.2.1 If there are two Coupons, the numbers of which are equally close to the prize number, the winner of the Offer is the Client, who has more Coupons.

5.2.2 If the Clients have the same amount of Coupons, the winner of the Offer is the Client, who has bigger trading volume made during the period of the Offer.

5.2.3 If the Clients have the same trading volume made during the period of the Offer, the winner of the Offer is the Client, who was the first to receive the First Coupon.

06 POSTING OF RESULTS
